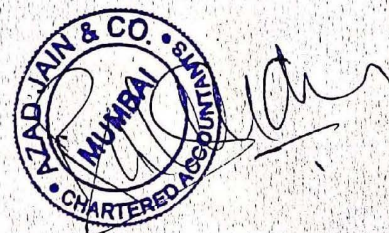


Review Report to
